HIGH NOON BUCKET SWEEPSTAKES OFFICIAL RULES

This Sweepstakes is intended for legal residents aged 21 or older of the United States (excluding Utah) and the District of Columbia. Void where prohibited. Do not enter this Sweepstakes if you are not eligible and are not located in the United States at the time of entry.

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

The High Noon Bucket Sweepstakes (the "Sweepstakes") will commence at 12:00:00 PM Eastern Time ("ET") on March 2, 2026 ("Start Date") and end at 11:59:59 PM ET on April 3, 2026 ("End Date"). The period between the Start Date and End Date will be referred to as the ("Sweepstakes Period"). The Sweepstakes Period will be broken out into three (3) separate entry periods (each, an "Entry Period") as set forth in the Entry Period Chart ("Chart") in Section 3 below.

- 1. SPONSOR/ADMINISTRATOR.** The Sweepstakes is sponsored by E. & J. Gallo Winery, 600 Yosemite Blvd., Modesto, CA 95354 ("Sponsor"), and is administered by Twelve Thirty, LLC, 980 N Michigan Ave, Chicago, IL 60611 ("Administrator") for Sponsor's High Noon ("Brand").
- 2. ELIGIBILITY REQUIREMENTS.** The Sweepstakes is open to legal residents of the United States (excluding Utah) and the District of Columbia who are 21 years of age or older as of the Start Date of the Sweepstakes. VOID IN UTAH, PUERTO RICO, U.S. VIRGIN ISLANDS, AND OTHER U.S. TERRITORIES AND POSSESSIONS, AND WHEREVER PROHIBITED OR RESTRICTED BY LAW. Directors, officers, employees, and agents of Sponsor, Administrator, and any retail licensees, authorized licensees, wholesale licensees, distributors, and each of their respective parent and/or sister companies, affiliates, subsidiaries, advertising and promotional agencies, and all other corporations, partnerships, or other legal entities or individuals associated with the development, administration, or fulfillment of this Sweepstakes, and the immediate families of such persons (defined as spouse, child, sibling, parent, son-in-law, daughter-in-law, grandparent, so-called "step" or "half" variations of any of the preceding individuals, and all descendants and each of their respective spouses, regardless of where they live), and those living in their same households, whether or not related, are ineligible to enter, win or collect prizes in the Sweepstakes. - 3. TO ENTER.** To enter visit sweeps.highnoonbuckets.com (“Website”) and follow the instructions to complete and submit the entry form during the Sweepstakes Period. The entry form may require, but is not limited to, submission of entrant’s date of birth, telephone number, entrant’s first and complete last name (no initials), email address, street address (no PO Boxes), city, state, ZIP Code, and that Entry Period’s Questionnaire. Once entrant has completed the foregoing, entrant will have earned one (1) entry (each an “Entry” and collectively “Entries”) into that Entry Period and one (1) Entry for the Grand Prize Entry Period. Entries must be received by 11:59:59 PM ET by each respective Entry Period End Date listed in the Chart below to be entered into that Entry Period. Any entry that is received after 11:59:59 ET PM on April 3, 2026 will be disqualified and that entry attempt will not be eligible for entry into the Sweepstakes.

Entrant may access the Website directly or by scanning the QR Code found on participating Brand promotional marketing materials. Scanning a QR code is simply an alternative method of accessing the Website and is not required to enter the Sweepstakes; all entries must be submitted via the Website.

LIMIT: Limit of one (1) Entry per person/email address per Entry Period. There will be a maximum of seventy-five (75) winners for Entry Period 1, one hundred eighty (180) winners for Entry Period 2, one hundred fifty (150) winners for Entry Period 3, and one (1) winner for the Grand Prize Entry Period. Winners will be determined by random drawing conducted by Administrator from among all eligible Entries received by Administrator on or about the date stated in the chart below. Potential Winners must respond within two (2) days of notification attempt. Failure to respond to notification as directed within the stated time will result in forfeiture of the prize. Entry Period 1 Prize(s) (75): Entry Period 1 will have a maximum of seventy-five (75) prizes. Each Entry Period 1 prize will consist of one (1) High Noon Branded Refrigerator. The ARV of each Entry Period 1 prize is \$299. The total value of all prizes that may be awarded for Entry Period 1 will be \$22,425

Entry Period 2 Prize(s) (180): Entry Period 2 will have a maximum of one hundred eighty (180) prizes. Each Entry Period 2 prize will consist of one (1) High Noon Branded Basketball. The ARV of each Entry Period 2 Prize is \$30. The total value for all prizes that may be awarded for Entry Period 2 will be \$5,400.

Entry Period 3 Prize(s) (150): Entry Period 3 will have a maximum of one hundred fifty (150) prizes. Each Entry Period 3 prize will consist of one (1) High Noon Branded Duffle Bag. The ARV of each Entry Period 3 prize is \$75. The total value for all prizes that may be awarded for Entry Period 3 will be \$11,250.

Grand Prize Entry Period (1): Grand Prize Entry Period will have a maximum of One (1) Grand Prize.
